**Fall 2019 Part-Time Evening Schedule (16 months)  
August 26, 2019 – December 19, 2020**

In the Part-Time Evening Schedule, classes are eight to ten weeks in length. Students take two classes per semester. Courses in the Part-Time Evening Schedule are delivered at a faster pace than in a traditional academic calendar. Students are expected to spend a significant amount of time each week, in addition to time spent in class, reading and reviewing course material and preparing writing assignments. The courses will move quickly right from the start and not slowly “ramp up,” as in a more traditional calendar. The courses follow a logical sequencing order in the schedule allowing students to build on concepts as they go through the program. Classes are offered at Roosevelt University’s Chicago Campus located at 430 S. Michigan Avenue.

The schedule offers a variety of delivery methods. Courses are conveniently offered on-campus, online, and in “hybrid” mode (combining face-to-face meetings and online interactions). The delivery format of each course is pre-determined by the program and the schedule meets American Bar Association guidelines with respect to online delivery of legal specialty courses. Pursuant to ABA guidelines, students must take at least ten semester hours or the equivalent of legal specialty courses through traditional classroom instruction.
