The **T**eacher **E**ducation **A**ssistance for **C**ollege and **H**igher Education (TEACH) Grant was developed by the U.S. Department of Education to provide up to \$4,000 a year to undergraduate and graduate students who are completing or plan to complete course work needed to begin a career in teaching. Eligible award amounts are determined by Federal requirements, grade level, and enrollment status on the date of award disbursement. The TEACH Grant can be converted to a Federal Direct Unsubsidized Loan that must be repaid with interest to the U.S. Department of Education when the teaching obligation is not fulfilled. Submitting this application is not a guarantee that you will be eligible or approved for the Federal TEACH Grant. Applicants must meet all 2023-2024 "Student Eligibility Requirements" for consideration. It is important to fully understand the teaching service obligation.

 - ACT Plus Writing: 22 composite core *and* a minimum of 19 Combined English/Writing
 - SAT: 1030 composite score (critical reading + mathematics) *and* a minimum 450 in Writing
