**Spring 2018 Chicago Part-Time Evening Schedule**  
**January 16, 2018 – May 10, 2019**

In the Part-Time Evening Course Schedule, post-baccalaureate certificate students are able to complete the program in a little over one year, taking one class at a time in seven, 8-week sessions and one, 6-week session. Students should expect that courses will move quickly right from the start and not slowly “ramp up,” as in the more traditional semester based calendar. However, students will be focusing on one course at a time, allowing for greater attention to each subject matter. The courses follow a logical sequencing order in the schedule allowing students to build on concepts as they go through the program.

Some courses will meet on campus in a traditional classroom setting two nights a week. Some courses will be available fully online and others will be offered in a hybrid format where the course meets one night per week on campus with additional online instruction to take place during the week. The delivery choice is determined by the program and the schedule meets American Bar Association guidelines<sup>1</sup> with respect to online delivery of legal specialty courses.
